ABSTRAK

Skripsi ini berisi penelitian yang bertujuan untuk mengetahui apakah perbuatan MR yang merusak pengcoran jalan khusus dapat dikenakan pertanggungjawaban pidana berdasarkan Pasal 63 ayat (2) Undang-Undang Republik Indonesia Nomor 38 Tahun 2004 Tentang Jalan. Terdapat pembangunan jalan di perumahan BP yang dibangun oleh PT CD. MR memaksa dan merusak pengcoran jalan dengan cara mencabut papan penahan cor-coran semen dan menginjak injak cor-coran yang masih basah sampai cor-coran jalan menjadi rusak. Hal ini, berarti perbuatan MR telah memenuhi unsur Pasal 63 ayat (2) Undang-Undang Republik Indonesia Nomor 38 Tahun 2004 Tentang Jalan. Terhadap MR dapat dimintakan pertanggungjawaban pidana karena telah memenuhi unsur-unsur pertanggungjawaban pidana.

ABSTRACT

This thesis aimed to determine whether the actions of MR who damaged the casting work on specific road could be subject to criminal liability based on Article 63 paragraph (2) of the Law of the Republic of Indonesia Number 38 of 2004 concerning Roads. There was a road construction within BP's real estate built by PT CD. MR forced and damaged the road casting work by removing the cement castings and stepping on the castings which were still wet until the road castings were damaged. This means that MR actions had fulfilled the elements of Article 63 paragraph (2) of the Republic of Indonesia Law Number 38 Of 2004 concerning Roads. MR could be charged with criminal liability because he had fulfilled the elements of criminal responsibility.
