ABSTRAK

Penelitian ini bertujuan untuk mendeskripsikan dan mengkaji regulasi distribusi jamu di Indonesia berdasarkan peraturan-peraturan yang mengatur tentang distribusi Obat di Indonesia, selain itu juga untuk menguraikan proses distribusi obat di berbagai Industri Obat Tradisional di Jawa Timur, dan juga memberikan informasi dan mengkaji terkait penjaminan mutu Obat Tradisional pasca distribusi. Metode penelitian ini dilaksanakan dengan pengumpulan data yang digunakan terdiri dari metode pencarian pustaka dengan menentukan kriteria inklusi dan eksklusi.

Berdasarkan hasil dari penelitian ini diketahui tidak banyak undang-undang yang diterbitkan oleh pemerintah pada 2017, dan banyak undang-undang mengenai Obat Tradisional pada tahun 2015. Dari Peraturan Menteri Kesehatan Nomor 006 Tahun 2012 Tentang Industri dan Usaha Obat Tradisional dijabarkan mengenai keamanan mutu, perizinan, izin edar untuk distribusi Obat Tradisional yang dilakukan PBF untuk memonitoring dan mengevaluasi distribusi Obat Tradisional Indonesia dari pembuatan hingga pasca distribusi.

ABSTRACT

This study aims to describe and examine the regulation of herbal medicine distribution in Indonesia based on the regulations controlling the distribution of drugs in Indonesia. In addition this study describes the process of drug distribution in various traditional medicine industries in East Java and provides information and review related to post-distribution quality assurance of traditional medicines. The study method is carried out by collecting data used consisting of literature reviews by determining inclusion and exclusion criteria.

Based on the results of this study it is known that there were not many laws issued by the government in 2017 yet there were many laws regarding traditional medicines in 2015. From the regulation of the Minister of Health Number 006 of 2012 concerning the industry and business of traditional medicines, it is described regarding quality of safety, licensing, distribution permits for the distribution of traditional medicines which PBF does to monitor and evaluate the distribution of Indonesian traditional medicines from manufacture to post-distribution.
