**ABSTRAK**

Salah satu unit terpenting dari Puskesmas adalah ruang farmasi, tempat penyimpanan obat *high alert* golongan Nama Obat Rupa dan Ucapan Mirip (NORUM) atau LASA (*Look Alike Sound Alike*), yang berpotensi sering terjadi *dispensing medication error*. Penelitian ini bertujuan untuk mengetahui pengelolaan obat golongan LASA terutama pada tahap penyimpanan obat di ruang farmasi puskesmas. Jenis penelitian ini adalah *narrative review*, menggunakan data sekunder berupa artikel yang dipublikasikan dalam jurnal ilmiah nasional. Penelusuran literatur diperoleh dari database *Google scholar* dengan kata kunci (Pengelolaan Obat), (*Look Alike Sound Alike*), dan (Puskesmas). Hasil penelitian dari 3 artikel yang ditelusuri menunjukkan bahwa terdapat beberapa puskesmas yang tidak melakukan pengelolaan obat terutama pada tahap penyimpanan dengan tepat, dimana ditemukan wadah obat LASA tanpa label atau tanda "*HIGH ALERT*" di Ruang Farmasi Puskesmas. Dapat disimpulkan bahwa terdapat beberapa kesamaan, yaitu secara keseluruhan puskesmas telah menata obat LASA berdasarkan bentuk sediaan obat dan alfabetis dengan cara diselingi 2 obat lain serta menerapkan sistem penataan dan penyerahan sediaan farmasi menggunakan metode kombinasi FIFO dengan FEFO.

**ABSTRACT**

*One of the most important units of the Puskesmas is the pharmacy room, a place for storing high alert drugs for the class of Similar Drug Names, Appearance, and Pronunciation (Nama Obat, Rupa, dan Ucapan Mirip, NORUM) or LASA (Look Alike Sound Alike). which has the potential for frequent dispensing medication errors. This study aimed to determine the management of LASA medications, especially at the drug storage stage in the pharmacy room of the puskesmas. This type of research is a narrative review, using secondary data in the form of articles published in national scientific journals. The literature search was obtained from the Google Scholar database with the keywords (Drug Management), (Look Alike Sound Alike), and (Puskesmas). The results of the research from the 3 articles that were included in this study showed that there were several puskesmas which did not manage drugs properly, especially at the storage stage where LASA drug containers were found without a label or "HIGH ALERT" sign at the Puskesmas Pharmacy. It can be concluded that there are some similarities in overall performance that the puskesmas has arranged LASA drugs based on drug dosage forms and alphabetically by interspersed with 2 other drugs and applying the FIFO and FEFO combination system for keeping and dispensing the LASA medications.*
