ABSTRAK

Perlindungan hukum bagi konsumen khususnya pengguna kendaraan bermotor sangatlah penting. Diterapkannya rangkaian pengujian oleh pemerintah melalui BPLJSKB sebagai upaya menjamin kelayakan suatu kendaraan sebelum jatuh ketangan konsumen. Rangkaian proses pengujian kendaraan bermotor di akhiri dengan dikeluarkannya sertifikat uji tipe. Pada faktanya beberapa konsumen masih mengalami kerugian akibat cacat produk mobil DFSK Glory 580 Turbo CVT yang telah bersertifikat uji tipe. Pada hasil penelitian diketahui bahwa perbuatan BPLJSKB tidak melanggar Pasal 1365 KUHPerdara. PT SA selaku produsen mobil DFSK Glory 580 Turbo CVT memiliki hubungan hukum lebih dekat dengan konsumen akibat dari adanya perjanjian jual - beli. PT SA. memiliki kewajiban untuk menjamin mutu barang yang diproduksi seperti pada Pasal 7 Huruf d Undang - Undang Perlindungan Konsumen sedangkan konsumen memiliki hak atas kenyamanan, keamanan, dan keselamatan dalam mengkonsumsi barang seperti pada Pasal 4 Huruf a Undang - Undang Perlindungan Konsumen. Adanya cacat produk mobil DFSK Glory 580 Turbo CVT dikarenakan oleh kegagalan proses produksi yang dilakukan produsen hal ini menyebabkan hak konsumen sebagaimana Pasal 4 Huruf a Undang - Undang Perlindungan Konsumen tidak dapat terpenuhi.

ABSTRAK

Legal protection for consumers, especially motorized vehicle users is very important. The implementation of a series of tests by the government through the BPLJSKB as an effort to ensure the feasibility of a vehicle before it falls into the hands of consumers. The series of motor vehicle testing processes ends with the issuance of a type test certificate. In fact, some consumers still suffer losses due to defects in DFSK Glory 580 Turbo CVT car products that have been certified for type testing. In the results of the study, it was found that the actions of BPLJSKB did not violate Article 1365 of the Civil Code. PT SA as the manufacturer of the DFSK Glory 580 Turbo CVT car has a closer legal relationship with consumers as a result of the sale-purchase agreement. PT. SA. has the obligation to guarantee the quality of the goods produced as stated in Article 7 Letter d of the Consumer Protection Act, while consumers have the right to comfort, security and safety in consuming goods as in Article 4 Letter a of the Consumer Protection Act. The existence of a DFSK Glory 580 Turbo CVT car product defect is due to the failure of the production process carried out by the manufacturer, this causes the consumer's rights as referred to in Article 4 Letter a of the Consumer Protection Act cannot be fulfilled.
